## Earning & Income

#### **Lesson Summary**

Ollie the Owl found the history of money lesson quite interesting. But what Ollie doesn't know is where money comes from, or how people get it. In this lesson, we are going to explore some of the ways people work to earn money. Additionally, we will explore some of the skills people need to work, and the types of jobs people do.

## **Discussion Time**

#### **Earning Money**

There are lots of ways you can earn and receive money, here are 5:


**1. Earning** – Many people work for an employer and are paid for their work, for example a bank employee.

**2. Self-employed** – Some people work for themselves. Joiners, plumbers and electricians are examples of people that can be self-employed.

**3. Inventors** – Sometimes people with great ideas or people who discover new ways of doing things more efficiently are paid for those ideas and new inventions.

**4. Promotion** - Famous people like sports stars get paid to say they like items such as clothes, food and cars.

**5. Gifts** – It is also possible to receive money from not working at all. One example is when people receive gifts, such as money we may receive on special occasions, like on a birthday.







#### Ann thought about becoming a vet. That changed!

When Ann was growing up on the family farm, she first thought she wanted to be a vet. All she could think about was helping sick animals get better.

When she began secondary school, Ann developed a keen interest in subjects like biology and chemistry. Then her focus began to change. She realised that while she would still like to help animals, she would like to help people even more. So she studied hard, applied her skills and eventually, Ann became a doctor.

Today, Ann works in Belfast for a firm that is developing cures for many illnesses. The money Ann is paid is called a salary. It is the income she earns from her medical expertise. Ann does not get to keep all of the money she earns. She must pay some of it to the government, it is called income tax.



#### What is income tax?

Tax is like sharing and it is used for lots of things in the community. When we pay tax, the money goes to our Government and it is then used to pay for roads, ambulances, teachers and even fire brigades.

#### Sean loves gadgets

Sean always had a fascination with gadgets and was always experimenting with how gadgets worked.

Sean applied to study Engineering in university, graduated and began his engineering career for a large company. There, he was paid a salary, this is income for the work he did each day.

But Sean always wanted to work for himself and he also wanted to make life better for others. So, he established his own small business developing medical devices and is now self-employed.

He soon developed a successful medical device that could regulate medicines for those with a range of illnesses. Patients recovered much quicker thanks to the devices that Sean invented. Soon, Sean was selling his invention to hospitals all over the world.

Eventually, Sean even began working with Ann. One day, they chatted about how he might be able to develop a suitable device that could be used to administer the medicines she was developing in Belfast. Sean went back to his original designs and created a new version of his medical device. Following this, Ann's firm realised it could now administer their medications more efficiently. So, while Sean and Ann had very different interests in school, when their paths crossed, they were able to combine their skills to help more people recover quicker from various illnesses.

## **Option 1:** Work for a company

- Earning money when you work for a company, they are required to pay you regularly.
- Flexibility your employer will need you to work to their requirements, which means you must be at work during set hours of the day.
- 3. Change you can move from one company to another if you like.

## **Option 2:** Work for yourself

- Earning money when you work for yourself, you may earn lots of money sometimes and less money at other times.
- Flexibility when you work for yourself, you can decide when to start work and when to finish work.
- Change when you work for yourself, you may do a variety of different jobs in the same day.




